Yield, diversification, low volatility

Ecofin Global Utilities and Infrastructure Trust plc (EGL) is a closed-end investment company domiciled in the UK whose shares are listed and traded on the London Stock Exchange. The Company carries on its business so that it qualifies as an authorized UK investment trust. EGL invests primarily in the equity and equity-related securities of utility and infrastructure companies which are listed on recognized stock exchanges in European countries, the United States and other developed, OECD countries although it may invest up to 10% of its assets in companies whose equity securities are listed on stock exchanges in non-OECD countries. It may also invest up to 10% of its assets in debt securities, which are typically traded on over-the-counter markets.

Investment objective: The Company's investment objectives are to achieve a high, secure dividend yield on its investment portfolio and to realise long-term growth in the value of the portfolio for the benefit of shareholders while taking care to preserve capital.

Yield: The Company targets a dividend yield of at least 4% on net assets using gearing and, if necessary, reserves to augment the portfolio yield.

Gearing: EGL may borrow up to 25% of its net assets to earn a higher level of dividend income and to offer shareholders a geared return on their investment. The Company pursues a flexible gearing policy, borrowing in major currencies at floating rates of interest under a facility which allows the Company to repay its borrowings at any time without penalty.


The Company distributes quarterly dividend payments of 1.6p per share, or 6.4p per share per annum. The first interim dividend was paid in December 2016; thereafter, quarterly payment dates fall on the last business day in February, May, August and November.

Manager's comments

- In a very challenging month for equities worldwide, the Company's NAV increased by 1.8%. Calendar year-to-date (to 31 May), the NAV has increased by 12.7% while the MSCI World Utilities Index has increased by 10.3% and the MSCI World Index has risen by 11.1% (all total returns in £).
- As the trade dispute between the US and China escalated (to also include the tech sector) and long-term bond yields resumed their slide, EGL's sectors in developed markets outside the UK continued to advance. The global utilities and listed economic infrastructure indices rose by 2.4% and 1.8%, respectively, in sterling terms. Sterling's fall against the US dollar (-3.1%) and the Euro (-2.7%) was a meaningful component of returns from overseas investments in May. The MSCI World Index declined by 5.7% in local currency (US dollar) terms and by 2.6% in sterling terms hampered by hefty falls in the US and emerging markets.
- With the ructions in the Tory party and Mrs. May's resignation, UK utilities were weak (-3.1%) as the prospect of the Labour Party in power, intent on nationalisation of at least parts of the sector, grew. SSE and Drax were the largest individual detractors from portfolio performance. Elsewhere, North American and Continental European holdings contributed positively in roughly equal measure with particularly good performances by NextEra Energy and Iberdrola which both recently reported earnings at the upper end of forecasts. Continental European companies tend to deliver a large proportion of their annual dividend during the spring and helpfully, several names in the portfolio (e.g. Portugal's EDP and REN, Engie, Suez, National Grid) went ex-dividend in a positive manner during the month.
- Gearing is unchanged at circa 15%.
- EGL's portfolio consists entirely of listed and liquid securities.

The Company may employ gearing. Whilst the use of gearing should enhance the NAV per share when the value of the Company's underlying assets is rising, it will have the opposite effect when the underlying asset values are falling.

The Company invests to a considerable extent in securities which are not denominated or quoted in Sterling, the Company's base currency. Movements in exchange rates will, therefore, have an effect, favourable or unfavourable, on the return on an investment in the Company's shares.

Gearing

The Company may make use of gearing to enable the Company to earn a high level of dividend income and to offer Shareholders a geared return on their investment. The Directors believe that the use of gearing is justified given the nature of most of the companies in which the Company invests; that is, companies which provide essential services, operate in regulated markets and within stable regulatory frameworks, and pay dividends. Whilst the use of gearing should enhance the net asset value (NAV) per share when the value of EGL's underlying assets is rising, it will have the opposite effect when the value of its assets is falling. As a result, the volatility of the Company's NAV will increase when gearing is being used which may also increase the volatility of the Company's share price. The nature and term of any borrowings are the responsibility of the Directors, while the amount of any borrowings is at the discretion of the Investment manager.

EGL may borrow amounts equal to 25% of its net assets. Any borrowings will be flexible, short-term borrowings in major currencies at floating rates of interest under a Prime Brokerage facility with Citigroup which allows the Company to repay its borrowings at any time without penalty.
